ABOUT THE CATHOLIC SCHOOL SCHOLARSHIP PROGRAM

Scholarships will be awarded by random drawing. All scholarship funds will be paid directly to the Catholic School listed on the application on behalf of the student by check for the 2019–2020 school year. Applicants must meet the following qualifications and are subject to the following conditions:

- Scholarship checks will be made payable to the school.
- Students must be a primary member with at least a \$5 balance. Applications will not be accepted unless account is open.
- Applicants must be attending or accepted into a Catholic School (Kindergarten – 8th Grade or High School).
- Limit one scholarship application per student. Student family can only receive one Catholic Vantage Financial Scholarship.
- Catholic Vantage Financial employees, elected or appointed officials of this Credit Union, and their immediate families are ineligible to apply. Immediate family is defined as parent, spouse, sibling, and children.
- Applications must be received by March 4, 2019.
- Scholarship Recipients will be notified by March 22, 2019.
- Failure to maintain your status at the Catholic School will result in cancellation of scholarship award and any remaining funds will be returned to the Credit Union and not redistributed.
