Dear Parents,

Since the stability of St. Edith Catholic School and the quality of its programs are of the utmost importance, we are always seeking ways to make improvements to benefit everyone. After much research and investigation, we have partnered with FACTS Management Company to help us manage our tuition payment program and financial aid assessment. We are excited to be working with them and are confident this program will offer greater efficiency and financial stability for the school while providing convenience to families.

One of our primary goals this year at St. Edith Catholic School is to concentrate our efforts on improving the *business side* of our school. By taking advantage of the security and convenience of payment processing and information technology offered by FACTS, we remain committed to this goal. A processing fee of \$45.00 will be charged to each family for the convenience of the Active Managed Payment Plan (AMPP).

You will realize these benefits by using FACTS for your tuition payment plan:

1. **Payment Dates:** You may choose from either of the following payment plans:
 1. **10 month payment plan** beginning in August 2018 and ending May 2019. Your family may select either the 5th, 15th or 20th of each month for payment. All contracts must be paid in full on or before May 20, 2019, therefore, any family beginning tuition payments after August of 2018 will have their tuition divided in even monthly amounts to meet the May 20, 2019 timeframe. Automatic payments can be made from a checking or savings account.
 2. **3 Payment Plan:** 3 automatic payments from either your checking or savings account in July, October and January. Your family may select either the 5th, 15th or 20th of each month for payment.
2. **Convenience & Security:** Along with multiple payment plan options, your payments are processed securely through a bank to bank transaction.
3. **Peace of Mind Insurance:** FACTS offers this optional benefit for only \$17 per year per family. In the event of death of the Responsible Party or spouse, the remaining tuition balance owed for the current school year is paid to the school.
4. **Online Account:** You may check your account balance, payment history, and make payments online from the convenience of your home or mobile device at any time.

One of the universal challenges in education is achieving a balance between our educational mission and financial stability. It is precisely for this reason we are enlisting the help of the FACTS Management Company. With FACTS, St. Edith Catholic School maintains decision-making control. As always, we will continue to work with families should special circumstances or "hardship" cases arise during the school year.
