## St. Edith Elementary School Kindergarten - Grade Eight 2018 - 2019 Tuition Plan Option

**All families must sign up for one of the following Tuition Option Plans when their 2018-2019 Registration Form is turned into the St. Edith Catholic School Office.**

### The Tuition Option Plans are listed below:

- **Option 1:** Paid in full for the 2018-2019 St. Edith Catholic School year on or before Wednesday, August 1, 2018.
- **Option 2:** Three equal payments due July 2018, October 2018 and January 2019. These payments may be electronically withdrawn from your checking or savings account through **FACTS on the following dates: 5th, 15th or 20th.** A processing fee of \$45.00 will be charged to each family for the convenience of the Active Managed Payment Plan (AMPP).
- **Option 3:** 10 month payment plan beginning in August 2018 and ending May 2019. Your family may select either the 5th, 15th or 20th of each month for payment. All contracts must be paid in full on or before May 20, 2019, therefore, any family beginning tuition payments after August of 2018 will have their tuition divided in even monthly amounts to meet the May 20, 2019 timeframe. Automatic payments can be made from a checking or savings account. A processing fee of \$45.00 will be charged to each family for the convenience of the Active Managed Payment Plan (AMPP).
