The Tuition Option Plans are listed below:

- **Option 1:** Paid in full for the 2023-2024 St. Edith Catholic School year on or before Monday, August 21, 2023. This option can also be checked if making a one time payment through **FACTS** and **payment is made on or before September 30th**. There is no processing fee charged by FACTS to families who enroll in a one time payment plan. Initials: _____
- **Option 2:** Two equal payments due September 2023 and January 2024. These payments may be electronically withdrawn from your checking or savings account through **FACTS on the following dates: 5th, 15th or 20th**. A processing fee of \$10.00 will be charged by FACTS to each family for the convenience of the Active Managed Payment Plan (AMPP) who enroll in the 2 payment plan. Initials: _____
- **Option 3:** Three equal payments due August 2023, October 2023 and January 2024. These payments may be electronically withdrawn from your checking or savings account through **FACTS on the following dates: 5th, 15th or 20th**. A processing fee of \$45.00 will be charged by FACTS to each family for the convenience of the Active Managed Payment Plan (AMPP) who enroll in the 3 payment plan. Initials: _____
- **Option 4:** 10 month payment plan beginning in August 2023 and ending May 2024. Your family may select either the 5th, 15th or 20th of each month for payment. All contracts must be paid in full on or before May 20, 2024, therefore, any family beginning tuition payments after August of 2022 will have their tuition divided in even monthly amounts to meet the May 20, 2024 timeframe. These payments may be electronically withdrawn from your checking or savings account through **FACTS on the following dates: 5th, 15th or 20th**. A processing fee of \$45.00 will be charged by FACTS to each family for the convenience of the Active Managed Payment Plan (AMPP) who enroll in the 10 payment plan. Initials: _____
- **Option 5:** 20 month payment plan beginning in August 2023 and ending May 2024. Your family may select either the 5th, 15th or 20th of each month for payment. All contracts must be paid in full on or before May 20, 2024, therefore, any family beginning tuition payments after August of 2022 will have their tuition divided in even monthly amounts to meet the May 20, 2024 timeframe. These payments may be electronically withdrawn from your checking or savings account through **FACTS on the following dates: 5th, 15th or 20th**. A processing fee of \$45.00 will be charged by FACTS to each family for the convenience of the Active Managed Payment Plan (AMPP) who enroll in the 10 payment plan. Initials: _____
